



 - "Satisfy" State Educational Requirements (PPA Certification)




What about the U.S. Department of Education?

The Title IV related regulations remain in place until there is an official action that takes place to vacate or amend the regulations typically through:

- New Rulemaking
- Congressional Action
- Judicial Action

Pain Point #2: General Understanding of SARA

Key Points of Confusion from Institutions

- Thinking they are Members of NC-SARA.
 - Conflation of NC-SARA and SARA.
 - Understanding SARA is an option to achieve state institutional approval.
- Thinking SARA created Professional Licensure requirements.
- Thinking that activities outside of SARA Policy are forbidden rather than understanding that state approval can be considered.



Access to SARA Specific Information

- Looking for state specific SARA requirements.
 - Some state websites are clearer than others.
 - State Portal Entity (SPE) Contacts on NC-SARA website indicates State SARA Website - not all link to SARA information.

Access to State Specific Information

Looking for state specific information to offer activities outside of SARA policy.

- Seeking consistency of information and active links on the state surveys for The Guide.
- Looking for information on state websites for approval

Who is looking?

- SARA institutions who also seek specific state approval.
- The institutions who more recently did not renew SARA participation.
- Institutions in a state that is not a member to the agreement.

Which programs are subject to the Federal regulations?



Applicable Educational Programs:

- Regulations address all modalities (includes Face to Face and Online)
- Designed or Advertised
- To meet educational requirements
- Leading to a license
- Required for employment in the occupation.

34 CFR 668.43(a)(5)(v)

Attestations: Certification Regulation Language Reminder

For the program to be eligible for Title IV – the institution must satisfy state educational requirements

- Where the institution is located.
- Where the student enrolled in distance education
 - On or after July 1, 2024.
 - Is located at the initial time of enrollment.

OR


Where the student attests that they intend to seek employment

34 CFR 668.14(b)(32)

How can the attestation option be used correctly?

- Student may be served even if the institution cannot satisfy state educational requirements where the student is located.
- IF the student attests that intention to seek employment in another state;
- The institution can satisfy state educational requirements in that state.
- Need more than the mere presence of the attestation document alone.
- No new attestation required if the student moves or changes their mind about future employment location.

What is required for SARA if the program is non-Title IV?



5.2 Programs leading to professional licensure


Any institution approved to participate in SARA that offers courses or programs designed to lead to professional licensure or certification or advertised as leading to licensure **must satisfy all federal requirements for disclosures** regarding such professional licensure programs.

For SARA purposes, these requirements will also apply to non-Title IV institutions and programs.

Institutions Asking How to Apply the Policy


Applicability:

- Programs leading to a license or certification.
- Could be non-credit programs.
- Could be for-credit programs the institution chose not to be approved for Title IV Aid.
- Only pertains to programs that are offered interstate obtaining approval through reciprocity.



What are possible state responsibilities outside of SARA?

- State Program Approval Possibilities (states & professions vary)
 - The actual program must be reviewed by the state.
 - The program must be registered in the state.
 - The clinical placement must be registered in the state.
 - The faculty member must be licensed to teach the student where the student is located.

 - Administrative Capability
 - o Financial Responsibility
